PANEL 1

SUSTAINABLE AGRICULTURE

John W Crawford FRSE

Professor of Strategy and Technology, University of Glasgow

John Crawford is currently Chair of Strategy and Technology in the Adam Smith Business School at the University of Glasgow. He is a theoretical physicist studying complexity at the interface between living and physical systems, using soil as a paradigm. For the past 9 years he has worked with the business sector to co-create data- and technology-enabled solutions that support integrated landscape management to address food and water security in the context of the global climate and biodiversity crisis. In 2015 he raised £13M to establish Agrimetrics, the UK Government's Centre for Excellence in big data for sustainable food systems, and was interim CEO. He established and currently leads the Global Soil Health Programme (GSHP), a consortium of global corporates and internationally leading soil scientists that is targeting health restoration on 60% of the world's agricultural soil. The GSHP is affiliated to the UN and has been invited to work with the World Economic Forum, businesses across the value chain, and farmers to help deliver a continental-scale transformation of the European food system to net-zero and Nature-positive. Most recently he is working with several impact funds to scale-up regenerative agriculture programmes in India, Kenya, Europe and the UK. His grantsmanship as lead applicant exceeds £50M, and he has published more than 200 peer-reviewed research papers with over 12000 citations. In 2003, he was awarded a Fellowship of the Institute of Mathematics and its Applications for services to mathematics, and in 2007 was elected as a Fellow of the Royal Society of Edinburgh in recognition of his contribution to science.



Gökhan Özertan

Professor of Economics, Bogazici University

Gökhan Özertan received his undergraduate degree from Boğaziçi University, Department of Economics in 1994 and his PhD in Agricultural Economics at Texas A&M University in 2001. He has been working in the Department of Economics at Boğaziçi University since the same year and is a professor in the same department. His research interests include modeling of agricultural and environmental processes, use of technology in agriculture, effects of climate change, commodity price movements, economic effects of intellectual property rights and regulations in the IT sector. He has studies published in prestigious academic journals.



This panel session will focus on business strategies to increase sustainability in the realm of agriculture. During this session, key regional and global challenges in agriculture will be presented by relevant stakeholders, and methods for the private sector to tackle them with public sector support will be explored.



Yvonne Colomer
Executive Director, Triptolemos Foundation

She has developed her professional career around the food system, in its different approaches: areas of research and development of new products, quality control, marketing and consumption, market research, international trade and education. Agronomic Engineer (University of Lleida-Spain), European Doctor on global food systems (Institut National Polytechnique de Lorraine, Nancy-France), MBA in International Agrifood Economics and Management (ESSEC). She obtained the title of piano teacher (Conservatori Superior de Música del Liceu - Barcelona). For 17 editions she directed the first MBA in management of agri-food business in Spain (University of Barcelona). Director of the UNESCO Chair “Science and Innovation for Sustainable Development: Global Food Production and Safety” and Secretary of the board of management 17 Campus Network Excellence. International consultant, member of various institutions and juries and speaker at different international Congress including the European Parliament. She has lectured extensively and has presented papers at national and international conferences and has contributed articles to leading journals and publications. She has a record of intellectual property on valuation methodology and consumer brands. Associate Professor at the Polytechnic University of Catalonia-Barcelona Tech (Spain). Since 2002 she has directed the Triptolemos Foundation.



Franck Gbaguidi
Biodiversity & Water Lead, Energy, Climate & Resources, Eurasia Group

Franck covers geopolitical risk across a range of sustainability issues, with a focus on biodiversity policy, water resources, and environmental litigation. As a member of Eurasia Group’s Energy, Climate & Resources (ECR) practice, Franck helps public and private sector organizations understand evolving sustainability trends and supports them in the design of solutions that turn political risks into opportunities. Prior to joining Eurasia Group, Franck held multiple energy and climate-related positions within the World Bank Group. Most recently, he was the Climate Adviser to the Managing Director of the International Finance Corporation (IFC). He also undertook research and consultancy work on carbon risk management for the European Investment Bank (EIB), clean and domestic energy solutions for the United Nations Capital Development Fund (UNCDF), energy policy in North America for the Centre on Global Energy Policy (CGEP), and environmental crimes in Sub-Saharan Africa for the Earth Institute. Franck holds three bachelor’s degrees and four master’s degrees, including a Master of Public Policy (Energy, Resources & Sustainability) from Sciences Po Paris and a Master of Public Administration (Energy & Environment) from Columbia University. He graduated from the Institute of Business Economics in İstanbul University between 1984-1986. Starting from 1986, he worked in different branches of the Food Industry. While he worked in many food companies his family owned, he also supported the establishment of many food companies. Mr. Duruk is still active in the managements of these companies that employs around 2000 people.

In 2021, he was elected to receive "Businessman of the Year" award by UN Food and Agriculture Organization and AO and Turkish Ministry of Agriculture. Mr. Duruk, who is married and have 2 children, knows English and German. He was a council member in İstanbul Chamber of Industry representing the Food Sector, and is an active member of multiple associations of food industry.



The inclusive business angle is particularly relevant for the agri-food supply chain, since it addresses the issue of poverty and integrating disadvantaged groups into the value chain by offering them to act as suppliers.
